#### **STAFF ACTIVITIES**

Office staff remain busy with customer calls, inquiries, work orders and questions.

The Technical Services Manager continues to with LAFCo on the 2023 Annexation and has started working on the encroachment permit for the temporary 4" HDPE pipe across the Peoria Road Bridge over Dry Creek.

The Manager and the Technical Servies Manager have been working with GEI on the EAP mapping update, and on the STID, DSSMP and ODSP update for Virginia Ranch Dam.

The Manager has completed the review of Chapter 6 of the Employee Handbook and has sent all comments to the consultant to create a draft handbook to share with the Personnel Committee. The Manager has also received the Draft 2024 Financial Audit from Blomberg and Griffin and is reviewing the report.

The Manager and Operations Manager were at Virginia Ranch Dam on July 31, 2025 for the Annual FERC inspection, which went very well, and no issues were found during the inspection.

#### **Sicard Flat Pipeline**

Fusion resumed the week of May 5, 2025 and continued through today, August 14, 2025.

#### **BVID Office**

The Geotech Engineer was at the BVID office on June 12, 2025 and the information has been sent to the BVID Engineer. He submitted the drainage study and the retaining wall design, which will need to be approved/signed by BVID staff prior to submitting for a grading permit.

The Sicard Pipeline construction crew has resumed work on Lanza Lane. Pipe is in the ground, backfill and cleanup are underway. Work on the temporary bridge crossing will begin on Monday, August 18, 2025.
