# STAFF ACTIVITIES

The Administrative Services Manager has been working on the list for the first round of shutoffs for non-payment, as well as managing the District's independent audit by Blomberg & Griffin.

The Technical Services Manager has been working on the 2023 Annexation project and assisting Henwood Energy with the data collection and processing for the VRD Hydro efficiency grant.

Operations have been very busy with service calls, repairs and the Sicard Flat Pipeline project.

MBK and Henwood Energy have been working on the VRD Hydro efficiency grant, and a draft application will be submitted for District review by the end of the month. The grant application is due June 20, 2023, and BVID/MBK have targeted a submittal date of June 16, 2023.

### **CURRENT PROJECTS**

#### **Groundwater Substitution Transfer**

There will not be a transfer in 2023, due to the exceptionally wet conditions.

#### **Conserved Water Transfer**

Option payment billing to Dudley Ridge and Santa Clara Valley have been received and processed. The CWT is unlikely due to excess conditions in the Delta.

#### **Sicard Flat Pipeline**

The US Bureau of Reclamation Environmental team has signed the Categorical Exclusion and issued the Notice to Proceed.

#### **BVID Property**

The survey work for the LLA is underway and the staff is working with real estate agents to determine fair market value for the parcel.

### **DISTRIBUTION MAINTENANCE / OPERATIONS**

#### **Upper District**

DSOD conducted the yearly inspection of Virginia Ranch Dam on May 11<sup>th</sup>. This year's inspection included cycling both the 42" Main butterfly and the Howell Bunger valve. The only issue noted was vegetation and some debris from the high-water flow.

VRD powerplant has been off intermittently due to some local outages, it is currently online.

The crew have been busy with many broken mainline repairs and service calls.

Sicard Pipeline crew began moving pipes to the project area last week. As of today, there is approximately 850 ft. fused together, we will install it in ditch sometime next week.

### **Lower District**

Pumpline is Running 58 cfs.

Unexpected high-water flow on Monday, May 22, inundated the fish screens causing them to go offline; this also caused the pond to empty, which shut the pumps off for about 12 hours.

The fish screens are still underwater, and the brushes are being cycled manually until water recedes and limit switch can be reinstalled.

On Tuesday, an unrelated electrical issue caused the pumps to be off for an additional 20 hours. Diamond Pump was able to find the issue and get the pumps back online around 3:00 pm.

<u>6. Director's Comments and Reports:</u> Director Bordsen commented that there is water near the road on Marysville Rd across from the post office and north of McMillan Dr.
