STAFF ACTIVITIES

On Monday February 12, the General Manager attended a tour of Shasta Dam, given by Ernest Conant of the Bureau of Reclamation, along with Yuba Water Agency staff and Yuba Accord Member Units.

The ongoing Lot Line Adjustment (LLA) is very close to finally being recorded. Below is a detailed explanation and breakdown of the LLA project.

The LLA application was submitted to Yuba County September 25, 2023 and on October 23, 2023 the General Manager checked in with Yuba County staff and was advised that 60 days is the typical turnaround time, additional title documents were needed and contact information for Cranmer

Engineering (CEI) was provided. On November 14, 2023, BVID staff received and reviewed the finalized legal description from Cranmer Engineering, which was resubmitted to Yuba County on November 16, 2023. The General Manager contacted the County Surveyor on November 20, 2023 to check in on the LLA status and received a response on December 6, 2023 that comments were resubmitted to CEI and the LLA should be recorded by the December 14, 2023 Board meeting. The revisions were received by the County Surveyor on January 4, 2024 and the General Manager was told by the County; the review should be completed by January 5, 2024.

On January 18, 2024 and January 31, 2024, the General Manager emailed the County Surveyor and followed up with an email to the Assistant Community Development Director, and BVID received a response from the Community Development Director on January 7, 2024 that the Surveyor is wrapping up his review. On February 14, 2024 the General Manager checked in with the County and CEI, and as of today, the County has provided all comments to CEI and the only outstanding item is final BVID signatures.
