#### **STAFF ACTIVITIES**

Collins Lake is spilling with a small rainstorm projected for Sunday and Monday. Don Moss was at the powerhouse on Tuesday, January 17<sup>th</sup> working on the small generator. The voltage regulator has failed since Don's previous visit, and he is looking for repair or replacement options. The large unit is being repaired and should be operational by the end of the month.

The Administrative Services Manager has been working on the 2023 Budget and Sicard Pipeline invoicing; the Technical Services Manager and the Manager have continued working with property owners to finalize the Sicard Flat Pipeline Upgrade project easements, as well as working on the potential 2023 Annexation. The Operations Manager has been busy with emergency repairs around the District and overseeing the preparations to the shop for the addition of another roll-up door.

Truckloads of pipe for the Sicard Flat Pipeline Upgrade continue to be delivered to the District, with much more on the way. The crew has been unloading and stacking pipe everyday with deliveries expected to continue through spring.

#### **Groundwater Substitution Transfer**

It is too early in the year to determine the probability of a 2023 transfer.

#### **Sicard Flat Pipeline**

The US Bureau of Reclamation Environmental team have completed most of the reviews for the Sicard Flat Pipeline Upgrade project and the District should receive NEPA approval soon.
