## STAFF ACTIVITIES

Collins Lake continues to spill at approximately 70 cfs and we are releasing an additional 72.2 cfs through the powerhouse. Don Moss was at the powerhouse on Wednesday, March 1 and was able to install the repaired heat exchanger and start the generator. He also repaired the voltage regulator on the small unit, and it is also running.

The Administrative Services Manager has started compiling the 2023 Billing, which will be mailed out to customers later this month. The Technical Services Manager has been working on the RES-BCT billing and easements for Mountain View Terrace and the Sicard Pipeline.

The Manager has been working on the 2023 Budget and reviewing the BVID/YWA Power Enhancement Agreement.

## **Groundwater Substitution Transfer**

It is too early in the year to determine the probability of a 2023 transfer but is unlikely.

#### **Conserved Water Transfer**

Option payment billing to Dudley Ridge and Santa Clara Valley were sent out, and there is interest from Dudley Ridge in pursuing the CWT.

#### **Sicard Flat Pipeline**

The US Bureau of Reclamation Environmental team have completed most of the reviews for the Sicard Flat Pipeline Upgrade project and the District should receive NEPA approval soon.
