STAFF ACTIVITIES

The Technical Services Manager has been working with Marcus Bole and Associates on the permitting to clean out the BVID Yuba River Diversion channel. He has received clearance from CDFW, Army Corps of Engineers, and the RWQCB. The diversion will be cleaned on May 23, 2025.

The Manager attended the Spring ACWA Conference in Monterey May 12-16. While at the Conference, I took advantage of water districts from north and south being in one location. I met with Yuba Water Agency staff regarding the BVID Conserved Water Transfer and the ability to transfer water in wet years

as well as the possibility of having a water transfer in 2025. I also met with Dudley Ridge Water District and Contra Costa Water District about the BVID conserved water.

A revised B120 will be released in June, which will determine whether or not a transfer will be possible. Dudley Ridge Water District is interested in the BVID conserved water, however, the ability to transfer depends on the capacity in the Delta.

Sicard Flat Pipeline

Fusion resumed the week of May 5, 2025.

BVID Engineer has contacted a Geotech firm for soils report to determine the compaction needs and the foundation type for the new office building. The Geotech Engineer will be on site May 28- June 3
